## The 2007 BGS Auctions

The Auctions started in February, 2007 with 20 bidders participating in the two Auctions. The BGS-FP Auction began on February 5, 2007 and finished on February 7, 2007 after 22 rounds. The minimum starting price was 11.4¢/kWh and the maximum starting price was 16.0¢/kWh. The results were as follows:

The BGS-CIEP Auction began on February 2, 2007 and finished on February 6, 2007 after 29 rounds. The 2007 BGS-CIEP Auction determined a capacity charge, unlike the 2006 BGS-CIEP Auction, which determined the Default Supply Service Availability Charge (renamed the CIEP Standby Fee). The minimum starting price was \$160/MW-day and the maximum starting price was \$215/MW-day. The results of the 2007 BGS-CIEP Auction were as follows:
