## The 2008 BGS Auctions

The Auctions started in February, 2008 with 22 bidders participating in the two Auctions. The BGS-FP Auction began on February 4, 2008 and finished on February 5, 2008 after 17 rounds. The minimum starting price was 16.0¢/kWh and the maximum starting price was 19.0¢/kWh. The results were as follows:
